### President's Perspective by Terry Tassin

I hope your Easter was happy and that you are all in good health. If you attended our March luncheon there was a little basket of Easter treats at each place - thanks to our own "Easter Bunny" Marie Fredricks. The lunch entree was very good, followed by a chocolate cake that was great! I would like to thank all of you who took part in the auction of the Phoenix Suns tickets, which were donated by Ron Drew. We raised \$270 for our Chapter scholarship fund.

Now let's get down to work.

Your help is really needed in a couple of areas. [We must stop the 10.6% Medicare/TRICARE cut.](#) Unless Congress acts, we're only three months away from a 10.6% cut in Medicare and TRICARE payments to doctors. That would dramatically reduce the number of doctors willing to accept military and

Medicare patients. Sen. Debbie Stabenow (D-MI) has introduced S. 2785, the "Save Medicare Act of 2008", to reverse the cuts and provide a 1.8% increase instead. Please send a MOAA suggested message or a letter urging your senators to cosponsor and pass this critically important bill. You can go to the MOAA web site at

Another area where your help is needed: recently, MOAA briefed almost 50 House staffers about DoD proposals to raise health fees for retirees under age 65 including raising copays for prescriptions that would make TRICARE's drug plan worse than half of all civilian plans. To help MOAA fight these disproportionate fee hikes, please take the time to send the tear-out post cards to your legislators included with the March edition of

your Military Officer magazine, which you should have received by now. Feel free to add a handwritten note at the bottom to give your letter an extra punch.

Now some good news. Each year, national MOAA takes time to recognize the councils and chapters that do an outstanding job communicating with their members during the annual Communication Awards contest. This year's contest drew a record number of entries, which were reviewed carefully by a panel of judges that convened at MOAA's headquarters in February. Each chapter was only allowed to compete in three areas of competition. Looks like we did well! Well Done to our Webmaster Tom Houser and Newsletter

## **Board Meeting Summary**

The Board of Directors met on March 6, 2008.

### **Officer/Committee Reports:**

**Treasurer's Report:** The present status of fund accounts:

General Checking: \$7070.23    Scholarship: \$8483.99    Total Accounts: \$15,554.22

Two sets of Phoenix Suns tickets for auction were donated by Ron Drew and proceeds to go to the scholarship fund.

**Legislative: Federal:** Gary Fredricks encouraged every member to use the pre-addressed cards to their senators and representative which encourage them to reject imposing unfair increases on military benefits. The pre-addressed cards can be found on the March issue of the Military Officer. **State:** The state budget deficit is forecast to be about \$1.2 billion dollars. However, the veteran's portion is fairly secure except for the hiring freeze which has been applied.

**Membership:** 165 of 209 members have paid their 2008 dues as of March 6. Dan Conway sent out 37 **Give Me 10** applications to Reserve Officers in the local area. The chapter has received a \$60 check from National Headquarters for the six new members recruited under the **2007 Give Me 10** program.

**Newsletter Editor:** Jim Cullison has stepped forward and volunteered to be the Sentinel Editor.

**Scholarships:** Ron Worthington reported that all notification letters have been mailed to the schools. The deadline for receiving applications is 25 March. There is enough Scholarship money to award a total of four scholarships if necessary. Scholarship selection committee consists of Ron Worthington (Chair), Ron Drew, Dan Conway, Chet Baumer and Ron Perkins.

**Arrangements:** Don Ford will provide entertainment at our October and December luncheons. The cost will be \$225. Dan Conway motioned that we book Don Ford for the mentioned dates and the motion was passed unanimously. It was also proposed the chapter have a silent auction for our October luncheon and a Chinese auction for the December luncheon. The proceeds go to the scholarship fund.

**Programs:** Terry Tassin reported that our February speaker had asked for feedback on her presentation on "Bullies in the Work Place". ### **Report on BOD Meeting:**

The FY 2009 budget plan is likely to include a DOD task force's recommendations to raise retiree TRICARE fees by \$1000 to \$2000 a year, depending on retired pay level.

### TOPS Tips

#### Common Résumé Mistakes

Many job hunters make the same mistakes over and over again in their résumés. A résumé will not get you a job, but a poorly written résumé can keep you from getting an interview that might lead to a job. Résumés don't have a perfect format, and everyone has an opinion on how to write one. So don't spend too much time trying to write the perfect résumé. More importantly, never pay anyone to write your résumé. You must write your own résumé because you will be the only one at the interview to defend it. Be careful to avoid the five common résumé mistakes people make. These mistakes could make the difference between getting an interview -- and a new job - or having your résumé pitched into the trash can. Continuing our series of résumé writing articles, here is:

**Mistake No. 4:** Your résumé focuses on positions and jobs you've held instead of results. Many résumés simply list the person's job description and performance objectives but don't list their accomplishments. Employers want to know what you accomplished and how well you executed your responsibilities. State in bullet format your most significant positions and accomplishments as they relate to the job you are seeking. Focus on the last five to eight

years because in today's technical world, system dynamics change so quickly you might date yourself, which could keep an employer from calling you for an interview. An example of a statement that demonstrates results might read, "Responsible for the staff of a large corporation's headquarters and tasked to reduce its structure. Within 60 days, developed and implemented plans that reduced the staff by 30 percent while simultaneously relocating to another region of the country." Another example might be, "Assumed responsibility for the maintenance operations of a large vehicle fleet. Reduced maintenance backlog by 50 percent in the first quarter and increased the overall operational readiness rate to 95 percent for the entire year."

**Mistake No. 5:** Your résumé has poor substance and format. A cardinal sin in résumé writing is having a misspelled word, followed closely by poorly constructed sentences or verb usage. Write like you talk. That's how most people read and write. If you are using words that are stilted or difficult for you to use, they also will be difficult for the reader and may send up a warning flag. Do not rely on your computer's spell check feature to scan your final product. Read and re-read your résumé, and ask friends to read it before you send it to anyone. Finally, before you mail or e-mail your résumé, call the employer's personnel office and ask for instructions regarding their preferences for transmitting it.

## Legislative Update

This month I would like to remind you of a couple of key actions you should be taking. You may well have already read about them in other MOAA media, but they are important enough to deserve repeating.

First, if you have not already done so, find your March edition of the MOAA magazine, *Military Officer*. Tear off the post cards, dealing with DOD proposed TRICARE fee increases, to your Congressmen that encase the cover, sign them, put stamps on them and mail them. They could save you a lot of money.

For the last two years MOAA and others have successfully headed off DOD efforts to substantially raise TRICARE fees. This year DOD is trying to raise them again backed by a congressionally mandated DOD Task Force report. The report recommendations, which were anticipated, would raise TRICARE fees by \$1000 to \$2000 per year depending on your income. MOAA letter/card writing campaigns like the present one have proven in the past to be highly effective with our Congressmen if enough of us actually send them in.

Second, use the MOAA website to send emails to your Congressmen on the Medicare and TRICARE payments to doctors issue. You will recall that legislation passed earlier prevented a mandatory cut in these payments from kicking in on January 1. But, the fix was only temporary. Unless Congress acts, we are less than three months away from a 10.6% cut in Medicare and TRICARE payments to doctors. That would dramatically reduce the number of doctors willing to accept military and Medicare patients. Sen. Debbie Stabenow (D-MI) has introduced S 2785, the "Save Medicare Act of 2008", to reverse the cuts and provide a 1.8% increase instead. All you have to do is go to [www.MOAA.ORG](http://www.MOAA.ORG), "Current Legislation", "Health Care Issues", "S-2785" and follow the simple instructions to send the emails. Together we can make a difference.

## Scholarship Info

As of this writing, the JROTC scholarship application deadline of 25 March is fast approaching, and we've received only a handful of applications. This despite follow-up letters and 37 phone calls to the senior military advisors at each of the 17 participating high schools. We'll continue our efforts until the suspense date to give more graduating cadets a chance to receive a scholarship to help further their higher education.

The Scholarship Committee this year consists of Chet Baumer, Dan Conway, Ron Drew, Ron Perkins and Ron Worthington. They will meet 9 April to evaluate the applications and establish a list of recommended recipients. These recommendations will then be submitted for approval to the Arizona Chapter Board of Directors at their May meeting. The scholarships will then be awarded later that month at the general membership luncheon meeting. Hope you can all attend.

**"Help Your Survivors Now"**

There are many things you can do during your lifetime to help your survivors after your death. When planning, it is important to be able to answer such questions as:

- What happens to your personal and real estate property when you die?
- Is your spouse able to write a check on your bank account?
- Does your spouse take title to your automobile?
- What about the insurance on your car?
- What about your fire insurance?
- Do you own stocks or bonds? If so, can your survivors reduce these holdings to cash or otherwise dispose of them? Can your spouse find them? Do your survivors continue to receive your retired pay and if not, when do payments stop?

Unless you have determined the answers to these and other questions, your survivors may not receive all the entitlements for which you have worked so hard

This is a publication which we have stressed before, but following the presentation of General Hoffman at our last luncheon, I believe it important to mention it again. It was of interest that General Hoffman noted that in his own experience, the trauma associated with the loss of a loved one is much reduced if the surviving spouse is aware that survivor planning has been completed.
