President's Perspective

On the Go in February

Early last month, several chapter members participated in the 9th Arizona StandDown for homeless veterans. Then later in the month a total of 39 members and friends received a special tour of the Boeing Helicopter plant in Mesa that makes the AH-64D Apache Longbow Attack Helicopter.

I want to thank all those members who participated in the Stand Down. It was a very enlightening and rewarding experience. Over 800 homeless veterans were helped out in many, many ways. See Jim Cullison's article in this edition of the Sentinel for a more detailed break down of the StandDown statistics and pictures. The chapter hopes to make the Arizona StandDown an annual community

service event.

On February 20, several chapter members and friends were provided briefings and a close-up tour of the Boeing Helicopter plant in Mesa by Doug Austin, Production Manager for Final Assembly of the AH-64D Apache Longbow. The briefings included excellent videos showing the combat capabilities of the AH-

64D and its survivability in combat. In addition to information on the construction of the AH-64D and its capabilities, Mr. Austin also provided insight to the unique management and leadership techniques used at the Mesa plant. He described the bottom-up approach to addressing problems on the line and praised the close working relationship between assembly workers and upper management. A very informative and interesting tour was enjoyed by everyone.

New ID Procedure at Luke AFB

Anyone requiring routine access to Luke AFB needs to register your ID card information with Luke Security now through June 30 due to a new biometric ID system being implemented as of July 1.

You can register 6 a.m. to 5 p.m. weekdays at the South or North Gate visitor information centers and the Base Exchange. The procedure requires you and/or your spouse to present your current ID card. The card information and your thumb or index finger are scanned into the new system. It just takes a few minutes. You do not have to get a new ID card unless your card was issued prior to the year 2000.

Hint: The Exchange table is often busy and can take longer. The North Gate is typically quickest.

Chapter Assists Homeless Veterans

The Arizona Chapter was well-represented at the annual Arizona StandDown for Homeless Veterans in February. Seventeen members and spouses volunteered more than 100 hours at the 4-day event, held at Veterans Memorial Coliseum in Phoenix.

It was a record year for the StandDown, with more than 800 veterans being assisted with donated clothing and shoes, legal aid, medical care, and help with Social Security, driver license/state ID cards, housing and employment. The veterans could even take showers, get haircuts, play table games and sleep overnight at the Coliseum if they wished.

Nearly half of those served are chronically homeless. Almost a third were living on the street or in shelters, while others were living in transitional housing or with family and friends.

Identity Theft

Among the many MOAA publications, one which could be very valuable is the Financial Planning Guide. Below is a part of the information included about Identity Theft.

Practical Steps You Can Take Now to Reduce Your Exposure to Identity Theft:

Pick up your mail promptly and deposit outgoing mail at the post office or in a post office collection box.

Review all bills and statements promptly and notify banks and creditors of transactions you do not recognize.

Review your credit report annually. Recent legislation allows you to receive a free credit report each year from the three national credit bureaus. For more information go to www.annualcreditreport.com

Guard your Social Security Number. Do not print it on your checks. If it is on your driver's license, contact your DMV to ask about other options.

Do not sign the backs of credit cards. Instead write "PHOTO ID REQUIRED."

Destroy documents with personal information that you do not need. A cross-cut shredder works best.

Home Computer Tips:

Install anti-virus software to prevent a worm or virus from compromising your computer files.

Password protect both your hard drive and sensitive files.

If you dispose of your computer, use a good software utility to "wipe" clean the hard drive. Do not simply erase files or reformat your hard drive.

When registering at a web site, provide minimal information. Never provide your Social Security Number. If you do not understand why certain information is required, then do not provide it.

Do not download files sent to you by

strangers or click on links in e-mails from people you do not know.

Travel Tips:

Stop the delivery of mail, newspapers and other items received on a regular basis.

Make your home appear to be lived in by setting lights on variable timers and arrange for someone to mow your lawn.

Put your work address on your luggage tags and use your first initial instead of first name.

Use a money belt or neck pouch to carry important items.

Do not take personal checks.

Take only the credit cards you need. If traveling alone, take two cards to avoid any inconvenience if one card is lost or stolen. If traveling with your spouse, insure that each brings a different card.

Take an ATM or debit card for extra cash. Memorize your PIN.

Legislative Update

MOAA's National Agenda

The President's FY2011 Defense Authorization budget proposal is now known, and it reveals no significant surprises. This allows MOAA's 2010 national legislative agenda to proceed pretty much on course.

The next major event will be the annual "Storming the Hill" campaign on April 21. For our visits to our Arizona legislators in Washington, I will be teamed with Bob Delker, the immediate past president of the Arizona Council of MOAA Chapters from our Superstition MOAA Chapter, and Mrs. Pat Schechter, a member of the National MOAA Auxiliary Members Advisory Committee from our Tucson MOAA Chapter.

The campaign this year focuses on authorizing an increased military pay raise, providing fair retirement credit for Guard/Reserve members activated since 9/11/01, and ending unfair penalties for disabled retirees and survivors including the DIC offset to SBP and concurrent receipt remaining issues.

Medicare/TRICARE Deadline Looms

As the Sentinel goes to press this month, the clock is still ticking on a very significant issue which could affect most of us adversely if not fixed. That issue, of course, is the looming 21% cut to Medicare/TRICARE doctor payments that is scheduled to kick in on March 1 unless Congress takes action to prevent it. We are still working the issue hard and hope to at least see the cut postponed once again as it has been for the past four years. A long term fix is not likely at the moment given the concern over the federal deficit and the \$250 billion it would add to that problem.

As we wait to see what happens, I thank those of you who sent in the pre-written MOAA e-mails to our Congressmen expressing our concern, and I urge each of you to stay alert for future MOAA national requests for support on this issue.

At the state legislative level the budget deficit remains unsolved, but some small movement in

breaking the partisan deadlock on progress seems to be surfacing. There is also considerable activity on several proposed bills that potentially affect us. As reported last month we shouldn't expect any of these new initiatives to surface that actually cost money to the state. But, it is encouraging to see some interest in the military/veteran community from our legislators.

The Action So Far

Last month at this time, there had been 34 of these new bills introduced, eight in the Senate and 26 in the House. Currently, there are 48 on record, 15 in the Senate and 33 in the House. That compares with the roughly two dozen that were introduced last year, of which a half dozen were actually enacted.

One of the bills, HB 2427 (military overseas voting; ballot arguments) passed the legislature and was signed by the Governor. Others vary from being passed in the Senate or House and pending action in the other chamber, through still being discussed in committees, to a few that haven't yet been heard by committees.

There are far too many in process to be able to discuss with any detail in this column. We are encouraged, however, to note that a small number of them which seem to be inappropriate are not progressing at all while others that are appropriate are making headway. As an example of the former, the "payday loan" issue is back, as well as an effort to divert special license tag fees from the Arizona Veteran's Donation Fund to a non-profit operating out of Florida. At the moment we believe things are going well, but stay tuned for any requests for support that may be forthcoming through our AZ Chapter MOAA E-newsletter.

A bill now in Congress, HR 4403, the Space-A Travel Act of 2009, would allow unremarried spouses of deceased retired service members to fly space available on military aircraft. The spouse's dependents also could travel space available if accompanied by the spouse.
