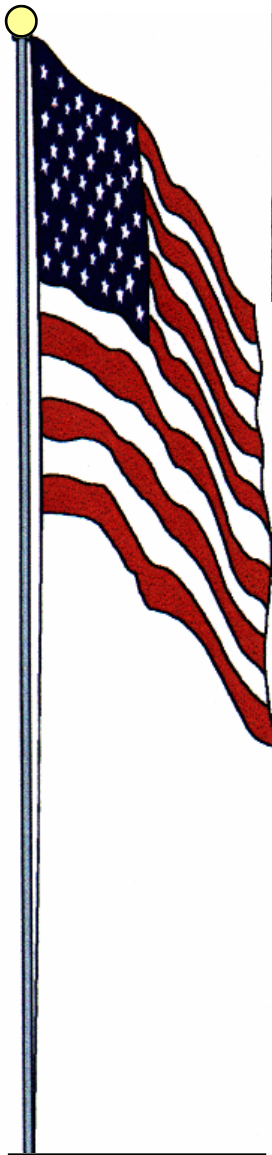

## PRESIDENT'S MESSAGE

It is with a great sense of responsibility that I sit down to write this message. Thanks again for your trust in me for the position of Chapter President.

I have reviewed in my mind what I consider the successes we Veterans have recently obtained. The leaders are, of course, TRICARE for Life (TFL) and the Senior Pharmacy Program (TSRx). Although both are for the 65 and over retirees, I'm sorry to say that that it will eventually affect us all. TFL has already caused a recalculation of TRICARE benefits that will impact the way providers view TRICARE. I just tested the system (TFL) as I recently had some surgery. During check-in, I received nothing but good remarks on TFL from the medical staff. Previously many would grimace when you mentioned TRICARE as the second payee as they suspected low payments for their efforts. From my understanding, TRICARE now uses a table/formula that gives a higher pay out schedule. Therefore, providers are starting to view TRICARE more favorably.

Many people have mentioned that pressing issues for the future are 1) Strength of the Country, 2) Concurrent Receipt (receiving both retirement pay and disability pay) and 3) Getting the Survivor Benefit Plan (SBP) increased from 35% to 55% for surviving spouses over 62. However, I consider them all as part of the Strength of Country issue. From what I've found out, Concurrent Receipt involves both the issues of the veteran getting military retired pay and veteran disability compensation, and a surviving spouse's concurrent receipt of SBP annuities and Defense Indemnity Compensation (DIC) for spouses of disabled veterans.

Experienced military people separating rather than making the military a career are adversely affecting strength of the country. When I first had the chance of separating in '65, being an engineer, I devised a formula with a total of 100 points to stay in or separate and the points came up 60 - 40 to separate. However, I transferred 11 points over to stay in for the patriotic factor that wasn't in my equation. If I had known about these two factors (Concurrent Receipt and the reduction of SBP) then, it would have been 100 - 0 to separate and I don't feel that at that time I would have transferred 51 points. Both Concurrent Receipt and SBP enter the equation to subtract from the attractiveness of making the military a career as both are long term benefits that override short term benefits - such as bonuses to stay in.

I will now get off my soapbox. Yes, we have made successes, but I feel that we may lose some of the benefits we have regained if we don't continue to speak out. I invite all members who haven't renewed to renew their membership and join us in these and other efforts.

I am looking forward to the March meeting where we gather at Falcon Field. You might even see a plane that you flew in or flew.

**Legislative - Federal**

Our major efforts this last month have been to support Concurrent Receipt, which might still have some hope. The current status is that the Defense Authorization Bill signed in December includes the House provision which authorizes Concurrent Receipt if the President offers funding and legislation in his FY 2003 budget proposal. In support of this position, Rep. Mike Bilirakis (R-FL), the original sponsor of concurrent receipt legislation is preparing letters to the President and House Budget Committee Chairman Jim Nussle (R-IA) asking for their support to make concurrent receipt a reality in 2002. The letter to the President urges him to include the necessary funds in the budget he is due to send Congress in February. The letter to Nussle urges the Chairman to include budget "headroom" for concurrent receipt in the FY2003 Budget Resolution, scheduled for consideration by the Budget Committee in March. Bilirakis is asking the 374 cosponsors of H.R. 303 to cosign the letters with him. We have asked all of our members with email to send messages to Representatives Hayworth, Kolbe and Pastor who are the Arizona cosponsors to have them cosign the letter.

**TRICARE for Life (TFL)**

We have become aware of a problem in TFL payments, which apply to claims for those providers such as the Mayo Clinic who bill for 115% of approved Medicare charges. There is no question that TFL will reimburse to the 115% level. However, there is currently a computer programming glitch that stops such payments. We have been informed by both TFL and TROA National that this problem is being addressed. We don't have a time schedule, but are assured that the problem will be solved soon.

**Legislative - State**

With representatives from the Legion, NAUS, Korean War Veterans, and other Veteran Organizations, I represented TROA at a hearing of the Arizona House Military and Veterans Affairs Committee considering reauthorization of the Arizona Department of Veterans' Services and the Advisory Committee for 10 years. The vote was unanimous with compliments to Pat Chorpensing for his management of the Department. We are fortunate to have him working for the Veterans in Arizona.

**TRICARE Senior Pharmacy (TSRx)**

One of our members has found out the 90-day supply available for a single co-payment from the Mail Order Pharmacy is not the same as three 30-day supplies. If the prescription is written for a 30-day supply with 11 refills, you are required to refill on a monthly basis, and you will be charged the appropriate co-pay on a monthly basis. The solution is to make sure that your prescriptions, which you intend to have filled from the Mail Order Pharmacy, be written for a 90-day supply.

Also make sure that your prescriptions, which you intend to have filled at your local pharmacy, are written for only a 30-day supply. If written for a month supply, which may be 31 days, you will be charged two co pays.
