Membership

Since the first of the year we have added seventeen new members bringing our total membership to 155 members consisting of 120 Regular members and 35 Auxiliary members.

We are working from a list of approximately 1500 individuals who live in our area of concern who are members of TROA but not members of a local chapter. 1500 solicitation letters, or 1500 phone contacts is beyond our capabilities. We are therefore concentrating on individuals who have most recently joined TROA National. We have corresponded with about 75 individuals so far and have received a positive response from 12 individuals. We intend to follow up with telephone contacts where the phone number is known.

It should be pointed out that personal contact by our members is the best source of new members. If you know someone or meet someone who meets the membership requirements of TROA, make the pitch. Scholarship

I am sure most of you are aware that our scholarship program is directed to two areas of recognition. We work with 15 local area high school JROTC units to provide recognition to 3rd year students who have shown exceptional leadership qualities. When Bill Johnson made the final award to a student at Shadow Mountain High School on 21 May, we completed that phase of our scholarship program. I would point out here that our chapter supports twice the number of schools of either of the other two chapters in the valley. That support would not be possible without the strong backing of our membership.

The second portion of our scholarship program offers cash awards to graduating seniors who are planning to go on to a venue of higher education. Last year we awarded four \$500.00 scholarships to students from three high schools (Navy JROTC). Because we had senior military instructors at some of our high schools suggest that it just wasn't worthwhile to apply for a \$500.00 scholarship, the Board of Directors this year upped the cash award to \$1000.00, the thought being that the larger award would generate more applicants next year. You will all have the chance to meet with this year's winners at the 20 June Dinner Meeting.

In case you wonder how our scholarships to JROTC cadets are utilized, please read the below correspondence from the second of last year's recipients from the Apollo High School NJROTC program.

Legislative Update

* The Department of Defense has proposed new rules to establish a "uniform formulary" (UF) for military pharmacy benefits. Pharmaceuticals would be considered to be on the uniform formulary list unless recommended for removal by a special DOD committee. The committee could recommend removal for drugs determined to be less clinically effective or less cost-effective than other drugs in the same therapeutic class. Under the proposed uniform formulary system, beneficiary co-payments would not change except for non-formulary drugs that would be \$22 or 20% of the cost.

The proposed new system is subject to public comment until June 11, and would not be implemented before Summer 2003 at the earliest. Lt Gen Nelson wrote to the TRICARE Management Activity on behalf of the membership expressing TROA's significant concerns over the proposed rule. He expressed concern that making the

new formulary excessively restrictive will set back retirees' trust in a program Defense and congressional leaders have touted as an earned and well-deserved benefit. He also expressed concern that the increase from \$9 to \$22 for non-formulary drugs is excessively high.

I have read the proposed rules, but can't determine the merits in that I don't know which drugs are non-formulary.

Take the Next Step in Protecting DD 214 Forms

The pot continues to smolder on the subject of who can gain access to one of our most cherished (and supposedly private) legal documents, our DD 214 Forms. Yes, it's true that for years we were encouraged to file these documents in the local courthouse or city hall so that when we died our survivors could have immediate access to them. What they didn't tell us was that almost anyone could have access.

They also didn't tell us how hard it would be to remove these documents from the public domain once we filed them. In fact, as we have come to find out, it is very difficult - so difficult that many state councils have suggested that TROA undertake a legislative initiative for the passage of a federal law that would both regulate how these documents are handled (i.e., who can access the information contained in them) and give the owner of the DD 214 Form the right to remove the document. Federal law fixes won't help on DD 214 Form protections, because the control of public documents stored in local jurisdictions is a matter governed by state and local municipal laws. Consequently, a number of TROA chapters and state councils have taken on this issue as a state-level legislative goal. *May TROAGRAM*
