**Legislative Update**

While a month ago things didn't look good, the Congress has been very busy and productive with several provisions which are of benefit to the military and retirees as recently reported in recent MOAA Legislative Updates.

On November 12th, the Senate passed the FY 2004 Defense Authorization Act. The final step for enactment into law is President Bush's signature.

In addition to concurrent receipt which we reported in last month's *Sentinel*, there are a number of further provisions in the Act that will improve benefits for members of the military community. Among them are:

\* **Military Pay Raise Comparability Process.** A permanent law change tying future military pay raises directly to private sector pay growth, as measured by the Bureau of Labor Statistics' Employment Cost Index (ECI). Current law specifies that raises for active duty, Guard and Reserve members after 2006 would otherwise be capped one-half percentage point below the average American's pay raise every year. MOAA has championed this change for years, in the belief that pay comparability has to be a fundamental requirement for a successful all-volunteer force.

\* **Additional SBP Changes.** Survivors of

service members killed on active duty will have the option to elect "child only" Survivor Benefit Plan (SBP) coverage. This will help many surviving spouses who now see their SBP coverage reduced by the amount of any VA survivor benefit. In addition, the new law tasks DOD and the GAO to conduct a study of military death benefits to include a comparison with private sector death benefits.

\* **Housing Allowance.** Service members will see an average housing allowance increase of about 6.5% in January. That will reduce median out-of-pocket housing expenses for each grade to 3.5% of housing costs in 2004, with a target of further reducing average out of pocket expenses to zero in 2005.

\* **Federal Long-Term Care Insurance Program.** Gray area Reservists (who have completed 20 years of service but have not attained age 60 and retired pay eligibility) will be eligible to enroll in the program.

\* **Commissaries.** The new law restricts Pentagon authority to contract out certain commissary functions and requires congressional notification of planned changes affecting more than 10 commissary employees.



\* **Reimbursement for Household Goods.** A new provision authorizes the Pentagon to enter contracts with moving companies that require the companies to reimburse military families the full cost of replacing any items lost or damaged during the move.

\* **Reserve Mobilization Reports.** The President must provide a report to Congress within six months on the numbers, duration, and skills of activated reservists since 2002; the Secretary of Defense must report within a year on the effects of the call-ups on reserve recruitment and retention and assess what changes may be needed in active and reserve component roles, missions, force structure, and capabilities.

\* **Reserve Health Care.** The bill directs a report on health care needs of the Reserve component, to include whether benefits need to be expanded beyond the limited new measures in this legislation.

During the week of November 17-22, both the House and Senate passed H.R. 2297, the Veterans Benefits Act of 2003. It will now go to the President for signature. Among its many provisions, H.R. 2297:

\* **Restores Dependency and Indemnity Compensation (DIC)** and certain other benefits for surviving spouses who remarry after age 57. (MOAA and The Military Coalition strongly supported the House plan for restoration at 55, but the Senate measure prevailed). Qualifying spouses who remarried at age 57 or older before enactment of the bill will have one year to apply for reinstatement of these benefits.

\* **Increases monthly educational benefits** for spouses and dependent children of members who died of service-connected causes from \$695 to \$788 for

full-time study, from \$522 to \$592 for three-quarter time study, and from \$347 to \$394 for half-time study.

\* **Extends VA's specially adapted housing grant** to severely disabled service members prior to separation from active duty service.

\* **Expands benefits eligibility to children** with spina bifida who were born to certain Vietnam-era veterans who served in Korea near the demilitarized zone.

\* **Eliminates the 30-day requirement** for POWs to qualify for presumptions of service-connection for certain disabilities.

\* **Expands the Montgomery GI Bill** program to cover self-employment training programs and entrepreneurship courses at approved institutions.

### Medicare Bill Affects Military Retiree Seniors

In addition to civilian pharmacy benefits covered by the Medicare Prescription bill that the Senate passed November 25, four items will impact on Medicare-eligible military retirees and their families. First, the bill will eliminate late enrollment penalties for Medicare-eligibles who want to enroll in Medicare Part B in order to participate in TRICARE for Life. Second, it will replace a planned 4.5 percent cut in Medicare payments to doctors with a 1.5 percent increase, thus encouraging doctors rather than deterring them from taking Medicare (TRICARE for Life) patients. Next, it will eliminate the annual \$1,500 cap on Medicare physical therapy payments. Finally, it will establish a means test for Medicare Part B participation, creating higher premiums beginning at the \$80,000 annual income level. The President has said he is anxious to sign the bill. [Source: Armed Forces News 11/26/2003]

### Include Cover Sheets With Prescriptions Faxed To TMOP

Extra care is needed by providers who fax prescriptions to the TRICARE Mail Order Pharmacy (TMOP).

According to TRICARE officials, many prescription pads used by providers contain embedded watermarks to prevent fraud and forgery. When prescriptions written on watermarked pads are faxed to TMOP, the watermarked area of the copy received at TMOP is black and unreadable or totally blank.

TRICARE is spreading the word among its customers to encourage providers to fax a cover sheet containing the provider's name and telephone number along with every prescription. This will allow TMOP to contact a provider when an unreadable watermarked prescription is received.

Officials noted that TMOP receives thousands of faxes daily and will make every attempt to track down providers as

The Air Force Personnel Disability Division's new Combat Related Special Compensation web page is up and running to give retirees direct access to CRSC information.

According to Col. Larry N. Van Buren, Disability Division chief, the new page furnishes all the information required for a member to submit and follow an application's progress.

Retirees who have submitted CRSC applications or who feel they may be eligible are encouraged to review the web site for the latest information on the CRSC program. Information will be updated regularly to include the dates of applications received that the board is currently reviewing and the latest guidance from the Department of Defense.

There will be no more CRSC weekly updates disseminated through the Air Force Retiree News Service (AFRNS); however, there will be occasional reminders about the web site and information on changes in policies or procedures will be sent out via the AFRNS as quickly as possible. \* O'Hare Airport Chicago was named after "Butch" O'Hare, US Navy Medal of Honor recipient. Butch's dad was an associate of Al Capone, and he quit the mob to ensure his son would be allowed to complete his academy training. Butch was killed during the famous Marianna's Turkey Shoot battle.



\* The Navy's first pilot completed his training on April 11<sup>th</sup> 1911 – LT Theodore Ellyson

\* The first military flight school, College Park US Army Flying School, was formed in College Park, MD on April 11<sup>th</sup> 1911, and the Naval Aviation Service was formed less than one month later, on May 8<sup>th</sup>.

April 25<sup>th</sup>, 1914: First US combat flight was off Vera Cruz, Mexico – also first plane to sustain combat damage – it figures!

\* What was the name of the organization that became NASA? (National Advisory Committee for Aeronautics was formed on March 3<sup>rd</sup> 1915, and became the National Aeronautics and Space Administration in 1958)

### In My Opinion

When the Chapter dues bill arrives, we all have to make the decision as to whether or not Chapter membership is worth the dues. Some of us think that it is.

We first look at the purposes of the Chapter, and determine if our Chapter is meeting those purposes which are as follows:

The purposes of the Chapter shall be to promote the purposes and objectives of the Military Officers Association of America (MOAA); stimulate love of our country and the flag; defend the honor, integrity, and supremacy of our National Government and the Constitution of the United States; advocate military forces adequate to the defense of our country; foster fraternal relations among retired, active, and former officers of the uniformed Services and their National Guard or reserve components; protect the rights and interests of active duty, retired, reserve, and National Guard personnel of the uniformed Services and their dependents and survivors; provide useful services for members and their dependents and survivors; and serve the community and the nation.

Being a member of National MOAA can support most of these objectives. Those of us who attend our monthly meetings know that the National purposes can be supported at a higher level by belonging to a local Chapter. For example, the National legislative efforts would not be nearly as effective without the Chapter support. It wasn't National sending in 8,000 emails an hour to get TRICARE For Life passed - it was the Chapter members who did that.
