Scholarship Committee

Most of you are aware that our scholarship program is concentrated in two areas of recognition. We work with 16 local area high school JROTC units to provide recognition to students who have shown exceptional leadership qualities. At last check, our chapter supports twice the number of schools of either of the other two chapters in the valley. That support would not be possible without the strong backing of our members. This past year we awarded 15 JROTC medals to 3rd year students in our area high schools.

The second portion of the program offers cash scholarships to graduating seniors who are planning to go on to higher education. We just completed a very successful year in the High School Scholastic Recognition business. We awarded \$1000 scholarships to two deserving students from area high schools.

Now, the Scholarship Committee would like to suggest a way to give to our high school youth in the year 2003. Arizona allows tax payers to give up to \$250 per family to a school activity of your choosing. You might consider making your donation to one of our high school JROTC units for their use in sending students to youth leadership conferences and a wealth of other activities. hold off on this donation for a few months, but work it into your planning. When you are ready, we can provide you with the names and addresses of our JROTC units.

Membership

As of the change of the year we had 166 members of which 50 were Auxiliary members. That's the good news. The bad news is that 98 of our 2002 members have not yet renewed for the year 2003. Undoubtedly, some of those members have simply forgotten or overlooked the fact that dues are now payable. We won't take any drastic action, like drumming you out of the corps, for 30 days anyway. The Chapter Bylaws stipulate that a member is delinquent if dues are not paid by 60 days after due (1 March) and the individual will be dropped from the rolls after 90 days (1 April). We do not want to drop anyone! But, we would like for everyone to square their account. How do you know if your dues are not paid? Check the mailing label and if it says 02 after your name—you are delinquent! If you have an 02 behind your name on the newsletter mailing label, a quick and easy renewal slip is included in this issue. An 03 or greater on your label means you are paid up through that year. We have been known to make the occasional mistake, and if you feel we have made a mistake in your status—call. The first place to call is the Treasurer—Bill Johnson. If he says he got your check we will correct the mistake.

If you know of someone who is not a member but fits our member profile, pass the information along to the membership chairman.

VA Agent Orange Claims Retroactive

A federal appeals court in San Francisco has ruled that Vietnam vets who contracted prostate cancer and diabetes related to Agent Orange exposure should receive retroactive disability benefits dated to the time they first filed a claim with the VA. The ruling of the 9th Circuit Court of Appeals sets a legal precedent that could extend to a wide range of illnesses associated with herbicides. The appeals court decision let stand a lower court ruling that held the VA incorrectly interpreted regulations to deny retroactive payments to vets who filed claims after early 1994.

A December 1999 U.S. District Court ruling held that all Vietnam veteran prostate cancer claimants and their survivors are entitled to retroactive benefits to the date of their first filing of their claim for service connection or survivor's benefits (as long as the prostate claim was not final before 25 SEP 1985). Also upheld by the appeals court was a provision in a 2000 ruling by U.S. District Judge Thelton Henderson, ordering the VA to provide retroactive payments to the estates of veterans who died before the VA paid the money they were owed. In addition to the prostate cancer, the appeals ruling also affects veterans who filed for adult-onset, or Type 2, diabetes which was added to the list in 2000. Being a member of National MOAA can support most of these objectives. Those of us who attend our monthly meetings know that the National purposes can be supported at a higher level by belonging to a Chapter. For example, the National legislative efforts would not be nearly as effective without the Chapter support. It wasn't National sending in 8,000 emails an hour to get TRICARE For Life passed - it was the Chapter members who did that. It isn't National fostering fraternal relations among retired, active, and former officers of the uniformed Services and their National Guard or reserve components - it is at the Chapter level where this is done. It isn't National which keeps you informed on local issues - it is at the Chapter level where this is done.
