President's Message

I ask everyone to mark three dates on their calendars. I will explain the significance of each date as we go along.

The first date is November 22 (our Chapter Luncheon). Two very important events will be happening at that luncheon. First, we will be presenting the Chapter Meritorious Service Award to several people and, the second is, the people in attendance will be electing the Chapter officers for 2004. If it will affect your decision to attend, remember, at this luncheon Jim Seidl has negotiated a complimentary glass of wine for each person in attendance.

The second date is December 18 which will be the Chapter's Annual Silent Auction. This will be held at 7:00PM at the Sunshine Hotel located at 3600 N. Second Ave, Phoenix (the corner of 2nd Ave and Osborn). This is a reminder to get any items that you may want to put in the auction to Dan Conway who again is the Chapter's person in charge. At this year's dinner we will have a special presentation of a pin to all that have been awarded the Chapter Meritorious Service Medal/Award. The Board of Directors authorized a pin to be awarded to all current and past people being awarded the Meritorious Service Award. However, acquiring them took longer than expected and they won't be available till December. The pin will either have a clutch so it can be worn on an article of clothing or have a smooth back so it can be glued over the shield on the name tag. The size is just right so it will fit on the Name Tag.

The third date is May 29th, 2004. I know this appears a long way off, but this will preclude a scheduling conflict with a very important

event: the dedication of the WW-II Memorial. Yes, the actual Memorial will be located in Washington, DC. However, it was decided that there are many that can't make the trip for the dedication; therefore, each state will schedule their own ceremony. The person responsible for arranging the ceremony for the State of Arizona briefed the attendees at the October United Arizona Veterans (UAV) meeting and outlined his initial plan. It will start off with a breakfast (probably at the Phoenix Civic Center), to be followed by various events and culminating with a ceremony at Bolin Plaza at about Noon. This is just my observation, but there also may be many booths located in the vicinity where food will be served and that will have information pertaining to Veterans Affairs. It hasn't been discussed yet, but the State Council of Chapters may have a booth where MOAA information and chapter applications for membership can be handed out.

It was fortunate that I was able to attend the last UAV meeting with Dan. Not only did I get the information about the WW-II Memorial ceremony there, but a representative got up and made a presentation on the importance of Veterans being visible. This means being involved with various veterans organizations and attending events while displaying some patriotic attire that distinguishes you as a veteran. This could be something like the MOAA pocket patch or your MOAA name tag. If the meeting calls for something more visible, then an organizational hat would be appropriate. Along with being visible to the eye you should be active by talking or writing to your Congressmen or the President, or your local leaders if it is a local issue.

Another very noticeable way of making a statement as a veteran is displaying a Veteran License Tag on your vehicle. It does have an effect on the thoughts of people that see it. I not only have a Veteran's Tag on my vehicle but have several veterans' organizational decals displayed and if anyone is interested in the effect this can have in how others treat you - just talk to me. I have a firsthand experience I can recount to you.

The first opportunity for being visible is to attend the Veterans Day parade in downtown Phoenix on November 11. From what I have heard the parade is getting smaller each year and instead it should be growing. If a member manages to break loose to watch the parade, please call me at (480) 595-8693 and brief me on your observations and how I might be involved in next years parade.

The speaker at our dinner at Treulich's on the evening of October 23 was very enjoyable. It was really good for us to hear first hand of the events in Iraq rather than just relying on the media and the news. First hand accounts are always better than second hand accounts. When watching TV we have to remember that people tend to grandstand in front of cameras, so what you see might not be the true story.

This is getting long, but I want to make a pitch for getting the Sentinel over the Internet if you have a computer and access to email. Not only is the print sharper but you are getting color wherever it is used. I print it out two-sided on my printer and it comes out great. Legislative Update

The following was published in the MOAA legislative update. It is a little complicated, but is a major step forward in the battle for concurrent receipt. House leaders, Senate leaders, and the White House have reached a final agreement on concurrent receipt which will benefit as many as 200,000 disabled retirees in two ways:

First, all retirees with at least 20 years of service and VA disability ratings of 50% or higher will see their military retired pay offsets phased out over a ten-year period starting January 1, 2004.

Second, the recently enacted Combat Related Special Compensation (CRSC) will be expanded to include all combat- or operations related disabilities from 10% to 100% ratings, also effective January 1, 2004. Currently, only those with qualifying disabilities rated 60% or higher or who have a disability associated with a Purple Heart are eligible. In both cases, Guard and Reserve retirees with 20 qualifying years of service (including those with less than 7,200 retirement points) will be eligible.

CRSC payments are in the amount of the VA disability compensation paid for whatever percentage of the member's disability rating is due to combat-related disabilities, as determined by the parent service. Retirees must apply to their parent service for CRSC payments, but there is no phase-in period for CRSC. DOD is discouraging all those not currently eligible for CRSC from applying until this provision is signed into law.

Disabled retirees rated 50% and higher

who do not elect CRSC payments should start seeing their retired offset phased out automatically, starting January 1, 2004. No application is expected to be required. For 2004, qualifying retirees should see their retired pay increase by a flat amount, depending on disability, as follows: \$750 for 100% disabled; \$500 for 90%; \$350 for 80%; \$250 for 70%; \$125 for 60%; and \$100 for 50%.

The remaining retired pay offsets would then be phased out over the following nine years. In 2005, they would get back another 10% of any remaining offset; in 2006, they would get back 20% of the remaining offset; in 2007, 30% of the remaining offset; and so on. By January 2014, disabled retirees with 50% and higher ratings will be entitled to full concurrent receipt of military retired pay and VA disability compensation.

Disabled retirees who qualify for both programs would have to choose one or the other. Because the CRSC program provides full payment immediately vs. the 10-year phase-in for concurrent receipt, legislators plan to allow an annual election option for those who are CRSC eligible. This recognizes that a retiree, who is 100% disabled but only 60% of that is due to combat-related conditions, may find it advantageous to elect full CRSC payments for a few years until the concurrent receipt payment rises to a level that exceeds the CRSC payment. Because CRSC payments are tax-free and non-disability retired pay is not, this could also figure into qualifying retirees' election decisions.

Designing specific procedures for retirees to make such elections is but one of the many administrative challenges the Defense Department will have to address in implementing the new authority.

The new agreement also calls for the formation of a special commission to review the VA disability system and recommend any needed changes. Of its 13 commissioners, at least 12 will have to be highly decorated veterans. Four will be appointed by the House, four by the Senate, and five by the Pentagon and/or the VA.

No More Foot-Dragging on Military Tax Fairness

On Wednesday, MOAA President VADM Norb Ryan, Jr., along with representatives from other military associations, joined Congressman Chet Edwards (D-TX) at a Capitol Hill press conference to focus attention on Congress's failure to pass H.R. 1307, the Armed Forces Tax Fairness Act.

The House and Senate each have passed varying versions of H.R. 1307 three times this year (unanimously), but senior leaders have failed to even try to

work out their relatively small differences. The bill would provide relief from unfair or inadvertent tax penalties imposed on thousands of active duty, Guard and Reserve members and surviving spouses.

It's absolutely outrageous that Hill leaders keep passing hundreds of billions of dollars of politically contentious tax relief for all sorts of others, but refuse to finish action on the military tax bill that every member of Congress has supported on multiple occasions.

This week, MOAA began airing ads on Washington-area news radio, asking listeners to urge House leaders - specifically, Ways and Means Chairman Bill Thomas (R-CA) and House Speaker Dennis Hastert (R-IL) - to get off the dime and finish this bill. To add your voice, use MOAA's toll-free hotline to Capitol Hill: (877) 762-8762. Ask the operator to connect you to Rep. Thomas' and Rep. Hastert's office, and tell the person who answers the phone that you want House leaders to stop the foot-dragging on the Military Tax Fairness Act and get it into law before they go home this year. Are You Eligible For A Bronze Star Medal?

World War II veterans who earned the Combat Infantry Badge (CIB) or the Combat Medical Badge (CMB) are eligible to receive the Bronze Star Medal (BSM). Army Regulation 680-8-22, which

governs Military Awards, states the BSM is authorized for all service-members who earned a Combat Infantry Badge or the Combat Medical Badge. The award of either of these badges is considered as a citation in orders of documentary evidence of exemplary conduct in ground combat against an armed enemy prior to 1 July 1947.

Executive Order 9419 dated 4 February 1944, which was superseded by Executive Order 11046 dated 24 August 1962, established the BSM. The BSM is awarded to any person who, while serving in any capacity in or with the Army of the United States after 6 Decembner 1941, distinguished himself or herself by heroic or meritorious achievement or service, not involving participation in aerial flight, in connection with military operations against an armed enemy; or while engaged in military operations involving conflict with an opposing armed force in which the United States is not a belligerent party. The BSM based on the award of the CIB or CMB before 1 July 1947 may be awarded by a letter application submitted to National Personnel Records Center, Medal Section (NRPMA-M), 9700 Page Ave, St. Louis, MO 63132-5100. Government Grave Marker Requests Made Easier

The Department of Veterans Affairs (VA) has revised its application form to make requesting a VA grave marker easier. The new form, Application For Standard Government Headstone or Marker (VA Form 40-1330), includes updated information about changes that expand eligibility for a government marker.

For deaths on or after September 11, 2001, Public Laws 107-103 and 107-330 made government markers available for use on veterans' graves that were already marked with privately furnished headstones or markers. Previous law prevented VA from furnishing markers when a grave was already marked.

The laws require the Secretary of Veterans Affairs to report to Congress by Feb. 1, 2006, on the effectiveness of this benefit and to recommend whether it should continue. One of the changes made to the application form will allow VA to report on this new benefit by tracking its use.

In January 2002, VA introduced a toll-free fax service for submitting applications. This service is available 24 hours a day, seven days a week, as an alternative to regular mail. Instructions, as well as the fax number, 1-800-455-7143, are on the VA website at

www.cem.va.gov. The application form on the website can be filled in and printed for submitting by mail or fax. Questions about a headstone or marker application can be directed to VA's Memorial Programs Service applicant assistance unit at 1-800-697-6947.

Funeral homes and veteran's service officers are finding they can reduce the time to process a request by up to seven days and avoid postage costs. VA handles more than 1,000 requests daily for veterans' markers.

Army Trivia

Origin of the term "**Shavetail**". In the old army, the Quarter Master corps was responsible for obtaining replacement horses or mules. The replacement mules would take a few weeks to learn the routines of the post, which was pretty much follow the leader and respond to the bell. Once trained, they didn't require much effort and always fell in line when the column's moved out. On the other hand, the replacements needed extra training - so they were identified by a "shaved tail". By the time the hair grew back, the mule was trained. Needless to say, the term "shavetail" was quickly associated with young lieutenants and others who were "green" - but that's another story.

Old Glory Backwards?

Many sharp-eyed civilians have noted an apparent oddity on the uniform sleeves of American soldiers: backward flag patches. Why is Old Glory flipped around like that?

Only the flag patches affixed to right shoulders of uniforms are reversed, so the blue field of stars faces forward. (Left shoulder patches aren't a problem, as the stars face forward without meddling.) The reversal was inspired by the age-old practice of carrying flags into battle.

When fastened to a standard, the American flag's blue-and-white portion is always closest to the pole. A flag bearer rushing into the fray, then, would naturally lead with the stars. In fact, it would be virtually impossible to lead with the stripes - the flag would simply wilt and wrap around the pole, rather than waving triumphantly in the wind.

For a soldier to lead with shoulder-borne stripes, the, might smack of cowardice and retreat, as if the flag toter were backpedaling away from the conflict. The official Army guidelines on the donning of flag patches add that the forward-facing stars give "the effect of the flag flying in the breeze as the wearer moves forward." So perhaps it's best to think of every soldier as a latter-day flag bearer, leading the headlong charge into battle.

It should also be noted that military flag patches are often trimmed with gold borders. This is in imitation of the gold-fringed flag, also known as the U. S. military flag. According to an executive order signed by President Dwight D. Eisenhower in 1959, the gold-fringed flag (and, by extension, patch-sized replicas) are to be used exclusively by the armed forces. That order isn't always obeyed, however; many federal courtrooms now feature gold-fringed flags, despite the fact that they should only appear during courts-martial. [Source: VFW AZ News May 2003]

Aviation Centennial Trivia

* Which member of the AZ Chapter was an elite pilot of Air Force One? (Chuck Finch)

The State of Arizona veterans' license plates serve a dual purpose. First, they identify that your family includes a member who has served in one of the uniformed services. Second, they provide support to the Arizona veteran's home with \$17.00 of the \$25.00 cost of the plates dedicated to the home. This is the most important purpose. At the present time, less than 2% of eligible veterans have purchased these plates. Possibly part of the reason is that they don't know that they are available. This excuse is no longer available to you. By purchasing the veterans plates when you registration is due for renewal, you will let your neighbors and other eligible veterans know that they are available by seeing them on your vehicle. Hopefully, that will encourage them to do the same. How about making it our goal to have 100% of our Chapter membership displaying these plates?

Please consider this request seriously when renewal time arrives.

COLA and Medicare Adjustments Begin January 1

Effective Jan. 1, 2004, cost of living adjustments of 2.1 percent will kick in for Social Security payments, military and federal retired pay, VA disability compensation and SBP annuities. This will mean \$19 more per month for an average Social Security retiree, or a rise from \$903 monthly to \$922 for an individual and from \$1,492 monthly to \$1,523 for a married couple. Meanwhile, the premium for Medicare Part B (Medical Insurance) will jump 13.5 percent, for a \$7.90 monthly hike to \$66.60. Because military retirees and spouses must be enrolled in Medicare Part B to be eligible for Tricare for Life, this represents an increase in the cost of participating in TFL.
