As for meetings, responses were heaviest in favor of luncheon meetings with alternating dinner and luncheon meetings and dinner meetings also well received. Weekday and daytime activities were only slightly preferred to weekend and evening events. ### One Down; One to Go.

The House completed action on its version of the FY 2005 Defense Authorization Bill last week which includes a 3 ½ year phase out of the SPB Widows Tax or so called Social Security Offset.

The Senate delayed action on its version until after the Memorial Day break. At that time, Senator Mary Landrieu will be offering an amendment to conform the Senate version of the Bill to the House version. This means that we must continue to get the message to both Senator Kyl and Senator McCain asking them for their support of the "Landrieu SPB Amendment" when it is presented..

### MOAA Raises SBP with President Bush - DIS

MOAA was pleased to be among four veterans' associations whose leaders were invited to the White House April 14 for a 35-minute private meeting with President Bush in the Oval Office.

The main purpose of the meeting was to provide an update on Bush's view of the Iraq situation and his determination not to abandon the U.S. mission to help Iraq establish a democratic government. But Bush also asked the association leaders about their primary concerns.

When it came time for MOAA President Vice Adm. Norbert R. Ryan Jr., USN-Ret., to speak, he cited MOAA's top goal of eliminating the unfair age-62 benefit reduction imposed on older Survivor Benefit Plan (SBP) annuitants. Pointing out that no other federal annuitants are subject to such a penalty, he asked for the president's leadership support to end this "military widows tax," as envisioned in Rep. Jeff Miller's (R-Fla.) H.R. 3763

and Sen. Mary Landrieu's (D-La.) S. 1916.

Bush showed familiarity with the issue. He asked about the cost and said he thought the Senate had approved something on this. Ryan cited the relatively small price tag (\$498 million over five years). He acknowledged that the Senate had, indeed, approved budget authority for an SBP fix in the budget resolution, but the issue is far from resolved, and leadership support for military survivors urgently is needed.

While Bush offered no specific commitment, it certainly can't hurt to have had the opportunity to focus his personal attention on this important issue

### New Rules for TRICARE Pharmacy Benefits - DIS

In early April, DoD published the final regulations governing the TRICARE prescription drug uniform formulary. The new rules, originally mandated in the FY 2000 National Defense Authorization Act, will eventually add a third tier of drug copayments for specific medications designated as non-formulary drugs. Here's how it will work:

For most medications, beneficiary copayments will stay at \$3 (generic) and \$9 (brand name). For medications that will be designated non-formulary, beneficiaries will see a higher, third-tier copayment:

TRICARE retail pharmacies: \$22 for a 30-day supply;  
TRICARE Mail-Order Pharmacy (TMOP): \$22 for a 90-day supply;  
Non-network retail pharmacies: \$22 or 20 percent of the cost, whichever is greater.

A newly established DoD Pharmacy and Therapeutics (P&T) Committee will propose which drugs will be put into the non-formulary third tier. They will include only drugs the committee determines do not have a significant, clinically meaningful therapeutic advantage, or are not cost-effective relative to other drugs in a class - considering safety, effectiveness, or outcome.

Before the Pentagon adopts the recommendations, it must consider input from a beneficiary advisory panel, which will include representatives from MOAA and other beneficiary associations.

Even after a drug is put into the non-formulary category, it still will be available for the \$9 copayment if a physician determines it should be prescribed in a particular case for reasons of medical necessity. This will require documentation from the provider that other medications in the formulary aren't effective for the beneficiary or have

unacceptable adverse side effects.

There has been considerable publicity that the new regulations went into effect on May 3, but it will be several more months before beneficiaries actually see any changes. The first meeting of the P&T Committee won't be held until this summer, and it will take several more months for the committee to complete its review of all the categories and make its recommendations. Further, there will be a delayed effective date (up to six months in most cases) once specific drugs are designated for non-formulary status. That will allow beneficiaries currently taking those medications to consult with their doctors about switching to a medication on the formulary or request continued use of that drug for medical necessity reasons.

We'll provide continuing updates on this issue as more information becomes available.

Note: Drugs obtained from military pharmacies will continue to be provided without a copayment.

### Reserve GI Bill Upgrades Sought - INFO

Over the past four years, GI Bill benefits for National Guard and Reserve servicemembers haven't kept pace with improvements for active duty members. Congress raised active duty GI Bill benefits by more than 43 percent beginning in 2001 but failed to consider proportional increases to the reserve program.

Sponsored by Reps. Frank LoBiondo (R-N.J.) and Mike McIntyre (D-N.C.), H.R. 4188 would raise benefits under the Selected Reserve Montgomery GI Bill (MGIB) to 50 percent of active duty benefits (compared to the current 29 percent) over a five-year period starting Oct. 1.

H.R. 4188 also would allow reservists who are activated for a cumulative total of 24 months active duty within a five-year period to enroll in the active duty MGIB program. MOAA and The Military Coalition urged implementation of both of these changes before Congress earlier this year.

### SBP Discharge Petition Offered - HILL

Rep. Chet Edwards (D-Texas) held a press conference on Capitol Hill April 28 to announce that, after being open for signature for only two days, 177 House members already have signed his Survivor Benefit Plan (SBP) discharge petition on H.R. 548, Rep. Jeff Miller's (R-Fla.) bill that would phase out the age-62 SBP annuity reduction over five years.

"Reducing survivor benefits to those

whose spouses have served their nation in the armed services is an insult," said Edwards. "If just 218 of the 329 cosponsors of H.R. 548 will sign the discharge petition, we can respect the sacrifices of our military widows with our deeds, not just our words."

Edwards was joined at the press conference by Rep. Bob Filner (D-Calif.); MOAA President Vice Adm. Norbert R. Ryan Jr., USN-Ret.; and representatives of numerous other military and veterans' organizations. All expressed the common theme that cosponsorship alone is meaningless and that SBP cosponsors must step up and back their statements of support with real legislative action.

"It's time to get upset about the lack of action," said Ryan. "In the military, we vow to leave no one behind. It's intolerable that the government has left our military widows behind for all these years. We need action this year."

"You [members of the military and veterans' communities] have the power to make this happen," said Filner. "You need to tell your representatives you expect them not just to sign on as a cosponsor, but to sign Representative Edwards' SBP discharge petition and bring it to the floor where they can actually vote for it. If they get enough mail, something will happen."

We encourage all MOAA council and chapter officials to contact their representatives and urge them to support Edwards' H.R. 548 discharge petition. Use the "Sign SBP Discharge Petition" Action Alert on MOAA's Web site (<http://capwiz.com/moaa/issues/alert/?alertid=5712326&type=co>) to send a pre-written message asking your legislator for support.

You also can encourage chapter members to use MOAA's toll-free Capitol Hill hot line, (877) 762-8762. Ask the operator to connect you to your representative's office, and tell the person who answers the phone that you want your Congressman to sign Edwards' discharge petition.

Although the discharge petition might not make it all the way to 218 signatures, we hope it will put pressure on the members of the House and Senate Armed Services committees, who began their work on the FY 2005 Defense Authorization Act in May. If we generate enough attention to this issue, they are going to have a hard time keeping an SBP annuity increase out of the final version of the bill that will be enacted this fall.

## DOD Releases New CRSC Guidance - HILL

In late April, DoD finally issued the long-awaited new rules for the processing of Combat-Related Special Compensation (CRSC) applications. The major change is expansion of eligibility to include all combat-related disabilities and inclusion of dependent compensation.

The new guidance also addresses two previously unresolved issues - namely, Special Monthly Compensation (SMC) and compensation for individual unemployability (IU). Both issues will be assessed after the services have determined which of the applicant's disabilities are deemed combat-related.

In the case of SMC, the services will have to resolve whether any of the combat-related disabilities constitute grounds for the SMC award. To make these determinations, the CRSC processing branches will be assisted by the VA.

Individual Unemployability (IU) determinations will be based on the retiree's overall combat-related disability percentage. If the services award CRSC at 60 percent or greater, and the applicant also has been determined by the VA to be unemployable, then CRSC will be paid at the 100-percent rate.

## Base Decals

The following information is mainly for individuals who utilize LUKE AFB facilities. It is recommended, if your Base Vehicle Decal indicates **04** you should get it updated now, or anytime prior to the end of the year, at either the DRMO (El Mirage Rd & Glendale Ave) or at the Pass & ID Section. The Pass & ID (Bldg 1150, 2d Floor) will only update issued decals, not issue new ones. If your present decal is in serviceable condition, get the number off the decal (DD Form 2220), usually 3 letters and 3 digits, along with proof of insurance, registration and drivers license, and have it updated now or prior to the end of the year when everyone must obtain new decals.
