Thanks to you who have renewed early. For the rest, I can only hope that our efforts have won your support for another year.

One of the initiatives we took during the year, with a view toward better service to our members, was the Chapter survey we did in the spring. Thanks to the nearly 50 of you who responded to the survey. You confirmed that we were doing most of the things that you wanted done and gave us some ideas on some things that needed work. As you desire, we continue to focus on communications. **The Sentinel** (Terry Tassin) and our web site (Tom Houser) won MOAA National awards for "best in class" publications and we continued to report legislative activity (Dan Conway) at each General Membership meeting. Dan was able to organize local support for and report success on ending the "widows tax" - SBP annuity cut at age 62 for our military widows, and in achieving concurrent receipt of military retired pay and disability compensation, among many other things.

Jim Seidel led the way toward moving to a better location, the Sunshine Hotel, for our evening meetings and arranged for a variety of excellent speakers covering such diverse topics as the Gulf War, Sky Harbor Airport and regional transportation. We were once again able to honor

and provide \$1000 scholarships to five outstanding young men and women graduating from high school in the Phoenix area (Dick Horn) and to provide JROTC medals to students at 16 area high schools (Art Parker). We added a "theme party", an Oktoberfest, to our activity agenda as well as a visit to a classic car display (Chuck Schluter). We concluded the year with a very enjoyable Christmas party and Silent Auction (Dan Conway) that took in \$1250 for our scholarship fund. We had two really fun golf outings (Bernie Conway) that also supported the scholarship fund, and we organized a Personal Affairs initiative (Bernie Conway) to better serve the needs of the membership. We did lots of other "stuff" which I won't bore you with anymore just now.

Let me close by thanking you all for your membership that allows all this to happen and to the BOD and committee chairs for their friendship and hard work. For 2005 Dan Conway and I will be switching MOAA chairs with him being your new Chapter President and me assuming his former duties as MOAA Arizona Council of Chapters President. I trust that you will all be as helpful to Dan as you were to me. Thanks again and let's have another great year.

If you need a copy of this booklet, I will have copies available at the January MOAA luncheon. I want to emphasize the importance of having this workbook completed. Judy and I went through our book last week, and it is really a good feeling to touch the documents your survivors will need to finish your transition into whatever awaits you in

eternity - (I hope you have been good!). Since we have completed our workbook, you cannot expect me to back off on you getting yours complete.

The checklist will also be available in our local Arizona Chapter MOAA website. <http://www.azchaptermoaa.org> Visit it now and then, and see what is in there. You may be surprised. There is also a wealth of information available on the MOAA national website at www.moaa.org including most MOAA publications available to download.

MOAA's LEGISLATIVE UPDATE: Thursday, December 23, 2004

Issue 1: Concurrent Retirement and Disability Payments (CRDP) Increase

In January, retirees receiving Concurrent Retirement and Disability Payments (CRDP) become eligible for the second step of a multi-year phase-out of the disability offset to military retired pay. The additional money will come in their February checks.

The FY2004 Defense Authorization Act authorized a ten-year phase-in of Concurrent Retirement and Disability Payments (CRDP) to eliminate the offset of retired pay for VA disability compensation for retirees with 50% or higher disabilities. These payments started with flat-rate amounts in January 2004 and will increase every year until the retiree's disability offset is eliminated in 2014. Because the phasing plan is relatively front-loaded, 94% of the retired pay offset will be recovered within the next five years.

Under the FY2005 Defense Authorization Act passed last October, retirees with disabilities rated at 100% will be removed from the phase-in plan and their full, service-based retired pay will be restored as of January 2005 (to be reflected in the February check).

If you already received a preliminary projection of your 2005 retired pay from the Finance Center that did not fully reflect a change in your concurrent retirement and disability payments, you should receive an updated 2005 retired pay statement within a month or two. It may or may not come before you receive the money.

The increases in retired pay will depend on the amount of retired pay waived for VA disability compensation. Amounts already restored in January 2004 were \$750 per month for 100% VA disability ratings; \$500 for 90%; \$350 for 80%; \$250 for 70%; \$125 for 60%; and \$100 for 50%. Subsequent annual increases each January will be based on a percentage of the remaining offset.

The payment for January 2005 will restore another 10% of the retiree's remaining disability offset. In January 2006, eligibles will get back 20% of the remaining offset; then 30% of the remaining offset in January 2007, and so on until January 2014, when eligible members will achieve full restoration of the retired pay they earned by service.

For eligible retirees who were retired for medical reasons (so-called "Chapter 61" disability retirees) with twenty years or more in service, the retired pay restoration amount will be based solely on the amount of retired pay they earned by service, if they had retired without any disability.

MOAA and The Military Coalition are continuing to work to expand concurrent receipt provisions to those not covered by CRDP or Combat Related Special Compensation (CRSC).

DECEASED MOAA SURVIVOR CHECK LIST FOR FAMILIES

- 1) Family contact Defense Finance & Accounting Center 1-800-321-1080 (USCG contact 1- 800- 772- 8724); USPHS (1-800 638-8744.) This call will generate the RSFPP/SBP/RCSBP/SSBP annuity application process. Retirement pay will terminate on the date of death of the sponsor.
- 2) Family notifies the Social Security administration at 1-800-772-1213. Social security payment amount will change to the member with the greater amount, effective the first day of the month of death.
- 3) Family informs the Veterans Administration, 1-800-827-1000 to avoid an overpayment.

**THE PREVIOUS ARE ALL BENEFIT / MONEY RELATED ITEMS AND ARE TIME CRITICAL.
ANY OVERPAYMENT MUST BE RETURNED.**

- 4) Family arranges mortuary services. (If it will be a Catholic burial, Pastor must be notified before Mortuary)
- 5) Mortuary normally will arrange for military honors at cemetery.
- 6) Family obtains 10 certified copies of death certificate.
- 7) Notify either the Survivor Benefit & Casualty Assistance office at Luke, 623-856-7834 ,the Army National Guard at 56th & McDowell, 602-267-2909, or the AZ Veterans Services Division, 602-627-3261 , located at 3333 N. Central Ave, Phoenix for an appointment. They provide Veterans Benefits Counselors to assist you through filing for survivor death benefits.
- 8) You will need the following documents available at your appointment time:
 - a) Death Certificate
 - b) Marriage Certificate
 - c) DD Form 214
 - d) Retirement Orders
 - e) ID card of deceased
 - f) SF1199A Direct Deposit Form (Get from your bank)
 - g) VA (NSLI) Insurance Number
 - h) Social Security Card of spouse

- 9) You may have accomplished some of the following at your casualty assistance briefing.
 - a) Survivor must get a new uniformed service ID card and have DEERS changed (at any ID card issuing office). Army Guard unit @ 56th St and McDowell, (602) 267-2700 or Luke AFB, (623) 856-7875 can handle this. Have a copy of the death certificate, and call to be sure DEERS is working.
 - b) Family contact administrator of other pension plans: federal, civilian, state or local government, or private sector.
 - c) For execution of a will or living trust, family contact military legal assistance office or private attorney, trust administrator & executor of estate
 - d) Family let service decedent affairs, retired activities office or MOAA representative Chapter know if there are any immediate needs or if help is needed to handle death arrangements.
 - e) Family contacts all insurance companies: health, life, car, real estate, & long-term care.
 - f) Family contacts all financial institutions: mortgage, bank, credit union, credit card, & investments.
 - g) Family change real estate deeds.
 - h) Family changes all joint ownerships.
 - i) Family check content of safety deposit boxes.
 - j) MOAA get family's permission to publish death in local MOAA newsletter and in the national MOAA magazine.
- 10) MOAA national, as well as the AZ Veterans, and other service organizations also put out a survivor checklist. Reference to these will insure that all bases are covered.

Issue 2: What's Your MOAA Membership Been Worth to You?

The legislative successes won by MOAA and others over the past five years are significant and impressive against any benchmark and have substantially improved the lives of almost everyone in the military community.

As we highlight one priority or another in any particular year, we regularly get questions from members along the lines of, "I support what MOAA is pushing this year for survivors (or last year for disabled retirees, etc.), but what has MOAA been doing for the (non-disabled retiree/active duty/Guard-Reserve/other) group of people I care most about?" We think even a cursory review of the accomplishments from 1999 to 2004 demonstrates we've been able to win major gains for every part of the military community. Obviously, these successes weren't achieved by any single organization. They were won by the combined efforts of MOAA, The Military Coalition, other military and veterans associations, and many thousands of individual members who pressed their legislators for action - and by the senators and representatives who acknowledged the pressing needs and did something about them. In certain cases, the Department of Defense played a strong supportive role, but many of the greatest victories (including TRICARE For Life, concurrent receipt, and repeal of the SBP "widow's tax") were accomplished despite strong Executive Branch opposition.

But anyone associated with the process will acknowledge MOAA's leadership role in most of these efforts. So we think it's worth taking a minute to highlight what kind of return MOAA members have received on their \$24 annual investment in MOAA dues.

TRICARE For Life: \$2,000 annual savings for life (\$4,000 per couple) for Medicare-eligible members who no longer need to carry supplemental Medicare insurance.

TRICARE Senior Pharmacy: An average of \$1,300 per year that Medicare-eligible members would have spent out-of-pocket on prescription drugs that are now covered by TRICARE.

Combat-Related Special Compensation (CRSC): For a 100% combat-disabled retiree, this can amount to \$27,000 a year or more, tax-free.

Concurrent Receipt: A retiree 100% disabled from other service-connected causes also may get back the same \$27,000 per year or more, starting in 2005. 50% to 90% non-combat disabled retirees will get back \$1,800 to \$7,000 or more, respectively, in 2005, and these amounts will rise substantially in the years ahead.

REDUX Repeal. Members who entered service after August 1986 are no longer forced to give up 20% or more of all future retired pay, as they would have been if the onerous REDUX penalties had not been repealed. This can mean hundreds of thousands of dollars over an officer retiree's lifetime.

Military Pay Raises: Years of effort to restore military pay raise comparability have added an extra 11% to active duty, Guard, and Reserve pay since 1999. And that means 11% more retired pay for the rest of these members' lives.

Military Homeowner Tax Relief: MOAA-led efforts saved thousands of military homeowners from being penalized tens of thousands of dollars in capital gains taxes simply because they were assigned away from home on military orders since 1997 - including refunds of taxes paid by many who had to sell their homes since 1997.



Tax Deduction for Guard/Reserve Drill Expenses. The same legislation restored a tax deduction for overnight lodging, travel, and other expenses directly associated with inactive duty training -- worth hundreds and even thousands of dollars a year for members who travel long distances to drill sites.

Guard/Reserve TRICARE. Guard/Reserve members now get 90 days pre-deployment coverage and 180 days post-deployment coverage with no deductible or enrollment fee. Selected Reserve members not on active duty will be able to purchase a year of subsidized TRICARE coverage for each 90 days served in a contingency operation since 9/11. Even the most conservative estimates value this coverage at \$1,000 to \$3,000 per year, depending on family size.

SBP Benefit Increase. By 2008, elimination of the "military widow's tax" for survivors age 62 and older will mean an additional \$4,000 to \$8,000 or more in SBP benefits for survivors of most retired officers, depending on grade, length of service and level of participation in SBP.

VA Survivor Annuity Improvement. Survivors of members who died of service-connected causes now can keep VA survivor benefits if they remarry at age 57 or older, and the benefit is reinstated for those who remarry at younger ages if the second marriage ends in death or divorce. This protects almost \$12,000 a year for the affected survivors.
