## Legislative Update

The new Arizona "Freedom" vehicle license plates finally became available on January 15. The "Freedom" plate is attractive and features a US red, white and blue flag in the background. Unlike the "Veterans" plates which can only be purchased by veterans, the new "Freedom" plates can be purchased by anyone. However, just like the "Veterans" plates, \$17 of the \$25 fee goes to the veterans benefit fund.

On January 30 Governor Napolitano signed into law Executive Order 2007-08 establishing the Arizona Veterans Research Council. This is an extension of the Veterans Task Force that was created in 2005. As a result of recommendations from the 2005 Veterans Task Force, state funding of over \$11.5M was made available in 2006 for supporting such things as a new Veterans Home in Tucson, a new Veterans cemetery in Northern Arizona and the hiring of 21 more Veterans Benefit Counselors (VBCs). In 2007 the Governors budget request includes funding for an additional 19 VBCs that were not funded last year in order to achieve the total of 40 new VBCs that were recommended by the 2005 Task Force.

There were several additional topics that the 2005 Veterans Task Force did not have time to fully consider but, nevertheless, recommended for further study at a later time. Those topics form the basis of the new Executive Order that establishes the Arizona Veterans Research Council. The Council is charged with forming subcommittees to research and make recommendations on issues including, as a minimum, reserve components benefit and recruitment plans, veterans and dependent education plans, service obstacles faced by rural veterans and ways to overcome

them, and benefit proposals for disabled veterans. The Council will make an interim report by August 15, 2007 and is charged with providing a final report to the Governor, the Senate President and the Speaker of the House by the first week in January 2008.

On the national legislative scene the Presidents FY2008 defense budget proposal is now on the street and looks very much like MOAA national had projected. In that the Task Force on the Future of Military Health Care which was established by Congress last year is not scheduled to make their recommendations until May, the Presidents budget proposal does not contain the specific large increases in TRICARE fees and pharmacy fees that we successfully headed off last year. However, it does assume \$1.8B in savings from as yet unidentified TRICARE fee increases, almost three times the savings assumed in the FY2007 budget request.

If you have not already done so, I urge each of you to tear out, sign, stamp and mail in the pre written and addressed letters (four grey sheets) regarding this defense budget issue that are contained in the February issue of Military Officer magazine to Senator Levin, Representative Skelton, Representative Hunter and Senator McCain. Also look for similar letters to your Arizona Congressmen that should be included in the March edition of the magazine. You can also visit the MOAA national website at [www.moaa.org](http://www.moaa.org) and forward prewritten emails to your congressmen as well. Once again, this year we will need all the grass roots support we can generate to make sure veterans, survivors and active duty folks get the fair deal they are fully entitled to.
