



A picnic luncheon meeting of the General Membership was held on October 15, 2011, at the McCormick/Stillman RR Park. President John Ady called the meeting to order at 1200 hours and opened with the Pledge of Allegiance followed by an invocation.

**Members Present:** John Ady welcomed all and began with introductions. Total people present: 48; 31 member/spouses, 17 guests.

**Minutes:** Dispensed with reading minutes from the prior meeting.

**Treasurer's Report:** Beth Cullison read Treasurer Bill Roscher's report from this month's board meeting: General Fund \$9,873.35 plus \$50 Petty Cash, Scholarship Fund \$10,465.14 for a total of \$20,388.49.

**Arrangements:** Marie Fredricks reiterated the November luncheon meeting will be held a week earlier on Saturday, November 12. John Ady thanked Marie for all her hard work coordinating meeting arrangements and for today's picnic luncheon catered by Famous Dave's Bar-B-Que.

**Auxiliary & Wives Activities:** Beth Cullison indicated we continue to host bingo at the Veterans Home the first Thursday of every month. Anyone interested in helping out can contact Beth on 602-482-3838. It's a very rewarding experience and truly appreciated by the veterans.

**Legislative Affairs:** Gary Fredricks reported the Super Committee recommendations to cut U.S. spending are due November 23. The recommendations could have direct impacts on active and retired military. Congress has until December 23 to vote on the Super Committee's proposal. Gary also reminded of the upcoming mandated cuts in TRICARE doctor payments unless action is taken to prevent them. He once again urged all members to send Congress the MOAA prepared letters available on the National MOAA website. MOAA has 92 paid staff members in Washington, D.C., with 11 lobbyists. For the fifth year in a row, *The Hill* congressional newspaper named MOAA the top lobbyist in the country.

**Membership:** Ron Perkins indicated National MOAA provided a list of potential chapter members that live in our area. Dan Conway mailed a letter to each of the potential members and board member volunteers are asked to make follow-up telephone calls to invite them to a chapter luncheon meeting. Our chapter currently has 215 members in good standing.

**Personal Affairs:** Dan Conway invited members to attend a Personal Affairs Workshop next Saturday, October 22, at the Scottsdale Senior Center, 10440 East Via Linda, Scottsdale. Dan said the workshop will cover estate planning including wills & trusts, a presentation from the state attorney general's office focusing on senior citizen scams, forms for establishing a living will, and instruction on completing the "book". **Ron Worthington:** John Ady expressed sorrow at Ron Worthington's passing. Ron was an active member of our chapter, previously serving as Vice President and Chairman of the Scholarship Committee. He will be missed. All members were encouraged to attend his funeral Sunday, October 16.

**Golf Tournament:** Pat Dale shared details of the upcoming golf outing, November 10 at the Starfire Golf Club in Scottsdale. This is the major fund raising event for our scholarship fund. **AZ Veterans Hall of Fame:** Two chapter members, Brigadier General Gregg Maxon and Colonel Rance Farrell, will be inducted into the Arizona Veterans Hall of Fame October 28. John Ady encouraged all members to attend the annual dinner for inductees.

**Chapter Donations:** John Ady said the Board voted to support the annual homeless veterans StandDown at the state fairgrounds with a \$500 contribution. The StandDown provides a variety of services to homeless veterans; a growing percentage are female homeless vets. A donation of \$200 was also agreed upon for the annual armed forces career day program and luncheon held at the McCormick Ranch Golf Club.
