February Speaker

An Incredible and Unplanned Journey Across North America

Alvar Nunez Cabeza de Vaca might not be a familiar name in American homes, but he and a small group of followers made a significant contribution to American history.

His tale was described by Dr. Paul Schnur at February’s luncheon.

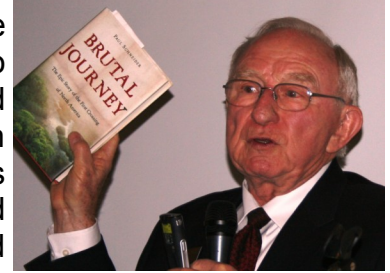
de Vaca was in a party of 600 conquistadors who left Spain in 1527 and after stops in the Caribbean put ashore in Tampa Bay in 1528, claiming Florida for Spain.

The group leader, Panfilo de Narvaez, split the forces, some marching north by land and others on ship to Cuba for supplies. The ships were never seen again.

Eventually, the land force, down to 242 men, built five boats and set a course for Mexico. The ships became separated, and a hurricane swept some of the men to Galveston. Narvaez died there, and de Vaca took over leadership.

The group was enslaved by Indians for four years, but in 1536 the four remaining survivors, including de Vaca, escaped. They trudged for two more years across what is now Texas, New Mexico and Arizona, then into Mexico, where the bedraggled foursome finally met a band of surprised Spaniards and told of their ordeal.

They became heroes in Mexico City, and de Vaca told of a legendary seven cities of gold. He was encouraged to lead an expedition to find the cities, but he declined, eventually becoming governor of Paraguay. He died in 1556. Another survivor, a Moroccan slave named Estevan, did lead Coronado’s search for the seven cities. He was killed by Indians during the search.

Member's Spotlight

Airmen Find Misadventure at Sea

Jim Cullison recounted the tale of two airmen who lost their way at sea and had to be rescued by some Chinese fishermen as the February Spotlight speaker.

Jim was one of 10 U.S. Air Force personnel at a Taiwanese Air Force radar site on the small island of Makung in 1967. Makung is about halfway between Taiwan and mainland China in the Taiwan Strait. Shortly after he arrived, the team's support base on Taiwan sent them a miniature sailboat —an oversized surfboard with a sail, as Jim called it—for their leisure recreation.

But on its maiden voyage, two airmen on board lost control and started drifting out to sea. Jim and a fellow lieutenant convinced a couple of nearby fishermen to take their boat out for the rescue. They returned from the rescue to the hearty cheers of a group of Chinese villagers and beachgoers that had assembled.

The lesson learned from the escapade? "It reinforced in our minds the fact that we were airmen and not seamen," Jim said. "And for the rest of my yearlong tour on Makung, nobody ever took that sailboat out again."

Home Safety for the Elderly

I had started this article when I learned that one of my friends had fallen and broken his hip. He was in his neighbor's yard with his neighbor when he tripped on a sprinkler head. He was very fortunate that he was not alone and he didn't hit his head. It could have been much worse.

Each year, according to estimates by the U.S. Consumer Product Safety Commission (CPSC), nearly 1 million people over age 65 are treated in hospital emergency rooms for injuries associated with the products they live with and use everyday. The death rate from accidental injuries in the home is approximately three times greater for older people than for the younger population, persons under 65.

Slips and falls are the main cause of injury for older people in the home. The CPSC recommends the use of grab-bars and non-slip mats in the bathtub, handrails on both sides of the stairs, and slip-resistant carpets and rugs. I will concentrate on ways to avoid falls.

Shoes with rubber soles will prevent slips. They don't have to be sneakers. Even more stylish shoes are available with rubber soles, and it's well worth the effort to find them.

Shoes should be tightly tied to prevent tripping on a loose shoelace. I often wear moccasins with leather laces which have a tendency to loosen. What I do is tie the lace with the shoe in my lap which enables me to make a much tighter knot, and then use a shoe horn to put on the shoes. With that procedure, I completely avoid the loose lace problem.

Lighting is another area to consider. You shouldn't be walking down unlighted hallways. If you don't have a light switch at each end of the hall, it is best to walk down the hall and turn on the hall light before you turn off the living room or family room light. The last light to shut off should be the one on your bedside stand.

A dark garage can be a special hazard. If your garage door opener light or your car lights

are insufficient or turn off before you get to the garage door, just leave on the garage light while you are gone. The little bit of power you use will be much less expensive than a hospital stay.

The CPSC believes that many of injuries to elderly persons in their homes result from hazards that are easy to overlook, but also easy to fix. By spotting these hazards and taking some simple steps to correct them, many injuries might be prevented. Use this checklist to spot possible safety problems which may be present in your home. Keep this checklist as a reminder of safe practices, and use it periodically to re-check your home. The checklist is organized by areas in the home. However, there are some potential hazards that need to be checked in more than just one area of your home. The checklist is available at:

But what if you do fall? If you are not alone, you can get help. But what if you are alone? The first thing to consider is a Medical Alert System which you carry with you at all times; usually on a necklace. The ADT system costs \$65 for installation and then a monthly cost of \$29. It has a range of 300 feet, so it works when you are outside. The other thing to consider is a KNOX-BOX. It is a secure box located outside containing a key to your front door. The only agency having access to the box is the fire department. It costs about \$200 and there is no monthly fee. For information on the KNOX-BOX, call 602-262-6771 in Phoenix or 1-877-229-5042 in Scottsdale or Fountain Hills. If you live alone, these measures should be mandatory.

One of my friends was home alone and his artificial hip slipped out. In addition to the pain, he was unable to move. He did have access to his cell phone but couldn't reach his wife. He could have called 911 but didn't want the front door to be opened with a fireman's axe. So he laid there for two hours until his wife returned and almost had a heart attack when she walked in on him. He got the KNOX-BOX so that didn't happen again.

Legislative Update

Where We Stand

As February winds down and March begins, where do we stand on significant near-term national legislative issues? After taking a 10-day holiday during late February, the legislature returned to Washington greeted by the following:

- The President's FY2014 budget request, which kicks off the FY2014 budgeting and funding program and is required to be submitted to the Congress by mid-February, was "missing in action" with little insight as to when or if it would be submitted.
- "Sequestration," which is a \$1 trillion, 10-year across the board budget cut with defense taking about half of it, automatically takes effect March 1 unless Congress adopts an alternative. Anything can happen, but it looks like both the President and Congress are willing to let it happen, at least in the short run. For an excellent 12-minute video on the probable affects of "Sequestration", I refer you to an interview by MOAA Director of Government Affairs, Steve Strobridge, which you can easily access at MOAA's website, www.MOAA.org, and click on MOAA Video: Sequestration and You.
- On March 27, the continuing resolution under which the federal government now is operating expires. This is the funding authority for FY2013, and failure to take further action shuts down the government, including the ability to pay our troops. There seems to be some conjecture that Congress might use action on this, or possibly combined with some movement on FY2014 funding, as a vehicle to also try to mitigate the impact of Sequestration. We'll just have to wait and see.

In the meantime the blame game goes on.

Here in Arizona

At the state level, *The Arizona Republic* indicates that 1,145 bills have been introduced in the state legislature. The Arizona Department

of Veteran's Services (ADVS) tracks those that have some impact on the military or veterans, of which there were 32.

We are about half way through the normal legislative session, and the first major milestone which requires bills to have been heard in committee in order for bills to progress has passed. *The Arizona Republic* indicates about 500 of the 1,145 bills that were introduced were not heard and have now passed by the wayside. Of the 32 tracked by ADVS, it appears only about half remain on track. They include:

SB 1287, which would raise the current \$2,500 military retirement and pension exemption from Arizona income tax to \$5,000, has been given a "Do Pass Amendment" recommendation in Committee of the Whole Senate.

HB 2076, which would give credit for military education, training or experience in meeting the requirements of a license or certificate of registration issued in Arizona, has passed both of the assigned House committees.

HB 2391, which would exempt all of an honorably discharged veteran's retirement pay from state income tax, has apparently died in committee with no action taken.

HB 2484, which would provide veterans hiring preference, veteran-owned business incentives and a tax credit to participating employers, has passed the first of two committees assigned for action.
