Secretary's Report: The minutes of the last meeting were circulated to the Board Members by Secretary Schnur. A motion was made and seconded that we dispense with reading the minutes. Treasurer's Report: Treasurer Charlie Bitner reported that we presently have \$7,158.89 in the general fund, \$27,091.84 in the Scholarship Fund, \$200.00 in petty cash for a Grand Total of \$34,650.73.

SPECIAL REPORTS;

AZ Council of Chapters –The Council is now taking on legislation to change fund for "Post 911 Vets". There is 6 million dollars in this fund and they are not able to use it as there is a limited number of Veterans in this category. This fund cannot be changed so there are those who want to end tax credits to the fund and transfer them to a similar fund run by ADVS. This will take an act of the State legislature. The Council is also supporting the drive to exempt military pension from Arizona State income tax.

COMMITTEE REPORTS:

Membership: David Price reported that we currently have 134 regular members and 27 surviving spouses for a total of 161. 68% have renewed their membership but 52 have
