**BOARD OF DIRECTORS MEETING – Thursday March 2, 2017**

**Call to Order and Pledge of Allegiance:** President Lee Lange called the meeting to order at 10:30 am at the Regional Training Institute, 5636 E. McDowell Rd. Phoenix, AZ. President Lange led the Board in the Pledge of Allegiance.

**ANNOUNCEMENTS:**

Outstanding legislators and business leaders who support veterans' issues will be recognized and scholarships will be awarded to high school students. **OFFICERS' REPORTS:**

**Secretary's Report:** Jim Draper moved, Bruce K. seconded waiving reading of Feb board minutes. All were in favor. Charlie B. moved and Janet Stultz seconded accepting minutes as written; all were in favor.

**Treasurer's Report:** \$7,007.08 in the General Fund, \$27,362.15 in the Scholarship Fund, \$200 in petty cash for a total of \$34,569.23. Charlie B. reported all required annual filings with the IRS and Corporation Commission have been made. There was discussion initiated by Charlie on the chapter's corporate makeup with separate corporations and bank accounts for the chapter and the scholarship fund. Wells Fargo won't allow Charlie to transfer funds between the accounts when the occasion arises; instead he has to write a check from one account to the other.

**SPECIAL REPORTS;**

AZ Council of Chapters – Lee Lange said the Council is encouraging all chapters to submit Level of Excellence nominations. Lee has submitted our chapter nomination. It appears MOAA might tighten up the award criteria because of the large number of LOE winners in recent years.

**COMMITTEE REPORTS:**

**Membership:** Dave P. reported we have 133 regular members, 27 surviving spouses for 160 total members. We lost two members last month, Martin Sours and Chet Baumer. Their spouses assume their membership. Lee sent letters to the spouses to express chapter condolences and offer assistance with receiving benefits due them. MOAA also sends a package with assistance information.

Dave distributed a list of 36 members who had not renewed their membership. Lee said a reminder letter will be sent to them in hopes they will renew by the March 31 deadline. Those who do not renew by that date will be contacted in person and encouraged to renew.

Lee said a plan will be developed to follow-up on a previous suggestion by Beth Cullison to leave our old copies of Military Officer in doctors' offices, to include information on MOAA and how to join. This was done several years ago when Chuck Schluter was president.

**Programs:** Bruce K distributed the list of remaining 2017 programs, including Pearl Harbor Survivor Jack Holder in March, ROTC scholarship presentations in April, Rep. David Schweikert in May, TBD in September, chapter barbecue in October, election of 2018 officers with speaker to be determined in November, annual Christmas party and presentation of individual chapter awards in December.

**Scholarships:** Jon Shawl reported that scholarship recipients have been selected by the scholarship committee. Each ROTC branch at ASU has a recipient – Army, Navy and Air Force. Jon will notify the recipients.

**Arrangements:** Donna B. reported that the luncheon contract for 2018 has to be signed in May. The board will consider luncheon pricing after the contract is signed, based on what McCormick Ranch charges us.

**Legislative Affairs:** Lee referred to his columns in The Sentinel, which discuss the budget and other issues. He reported there are 2 bills in the State Legislature that have significance to veterans: the Military Welfare Relief Fund bill and the veterans pension state income tax exemption bill. Both are moving through the legislature, although the income tax bill had to be resubmitted in a strike-all bill after it was killed in a committee. Lee encouraged members to attend a House Committee session on the income tax bill on Monday, March 6, to show support for the bill.
