I'm happy to report our membership for early 2024 is beginning to increase a bit. My personal thanks to our members who are recruiting new members! Good on ya! Every member is highly valued by our chapter's leaders. The more the merrier! We're valued by MOAA's leaders, too, because there is power in numbers, and in Washington, DC, numbers = lobbying influence.

Those of us who are age 65+ enjoy the benefits of Tricare For Life (TFL) which brings huge cost savings for most of us. Do you remember 'the old days' when we had CHAMPUS to contend with? That program was 'ok' but had many shortfalls. In 2005, very thankfully, there was enough support in Washington to introduce and legislatively pass the various forms of TRICARE, including TFL. Every time my wife or I find it necessary to get medical care, I'm so thankful for the major effort MOAA

devoted to lobbying on our behalf back in the day for this hard-earned benefit. So, why is your chapter Membership guy talking about this? Well, it's no secret that it takes money to do anything and funding MOAA is vitally important now. Much of MOAA's income is derived from membership fees and dues. The bottom line is, for our members who have either BASIC or PREMIUM (annual) memberships, I want to urge you to consider upgrading to a higher membership level. Yes, it does cost more to upgrade, but I dare to say it costs much less than many medical services TFL pays for on our behalf. And please think where we'd be if MOAA hadn't lobbied so tenaciously for us to have TFL. There are other benefits to upgraded membership levels. We really need to appreciate their work and support them whenever possible.

Congress Finally Acts to Fund Government

The Senate passed a \$1.2 trillion package of spending bills in the early morning hours of March 23rd, nearly six months into the budget year, pushing any threats of a government shutdown to the fall. The President signed the bill into law later the same day, funding the government for the rest of FY 2024, which ends September 30th.

Prospects for a short-term government shutdown had appeared to grow Friday evening, March 22nd, after Republicans and Democrats battled over proposed amendments to the bill. Any successful amendments to the bill would have sent the legislation back to the House, which had already left town for a two-week recess. The House passed their version of the bill early on March 22nd.

But shortly before midnight Senate Majority Leader Chuck Schumer announced a breakthrough agreement.

While Congress has already approved money for Veterans Affairs, Interior, Agriculture and other agencies, the bill approved March 23rd is much larger, providing funding for the Defense, Homeland Security and State departments and other aspects of general government.

Looking Ahead

With the FY 2024 appropriations finally

funded, MOAA is turning their attention to the FY 2025 budget released March 11th by the White House.

Here are some of the issues addressed by the annual request:

Pay Raise: A 4.5% increase for the uniformed services, in line with the statutory Employment Cost Index, for implementation in January 2025. Given the president's inclusion of this important compensation measure, it is now more likely to take effect either on its own or through the National Defense Authorization Act (NDAA) later this year.

Housing Allowance: No request to increase the Basic Allowance for Housing (BAH) rate beyond the 95% floor required by statute. While disappointing, when MOAA had the opportunity to question senior DoD officials about this decision, they cited the limitations placed upon them by the Fiscal Responsibility Act, which only authorized a 1% increase in DoD funding for FY 2025.

Basic Needs Allowance (BNA): Enhancement to the existing BNA, boosting the eligibility threshold from 150% to 200% of the federal poverty guideline based on family size.

Health Care: No TRICARE fee increases proposed. The Defense Health Program (DHP) FY 2025 funding request is \$40.3 billion, up 4.9% from the FY 2024 request. Approximately \$20.6 billion, or 51% of the DHP budget, is for private sector care supporting the provision of the TRICARE benefit.

Millions of Vets Exposed to Toxins Eligible for VA Health Care on March 5th

Millions of U.S. veterans are eligible beginning March 5th for health care with the Department of Veterans Affairs under an accelerated effort to provide benefits and services to those exposed to toxic substances while serving.

The VA announced that all veterans who have served in a combat zone since the Vietnam War, as well as those who participated in training or operations and came into contact with hazardous materials, will be able to enroll in VA health care.

The expansion of health care benefits was mandated by the [PACT Act, signed into law by President Joe Biden in August 2022](#), which required the expansion to occur by 2032. VA officials said last month the

acceleration is a result of a hiring blitz made possible by provisions in the law.

Under the PACT Act, more than 100,000 veterans have enrolled in VA health care and roughly 760,000 disability claims have been approved. VA officials did not detail exactly how many veterans now will be eligible for care under the expansion but said the figure is in the "millions."

The expansion allows all veterans who deployed to combat zones in support of the Vietnam, Persian Gulf, Iraq, and Afghanistan wars to enroll in VA health care.

In addition, veterans who never deployed but were exposed to pollutants while participating in a known "toxic exposure risk activity," or TERA, either in the U.S. or abroad, will be eligible.

That would include exposure while on active duty, active-duty training or inactive-duty training to: air pollutants from burn pits, particulate matter, sulfur or oil well fires; chemicals such as pesticides, herbicides, contaminated water or depleted uranium from embedded shrapnel; occupational hazards such

as lead, industrial solvents, toxic paint, asbestos and firefighting foam; radiation, including nuclear weapons handling, maintenance and detonation, X-rays and occupational exposure; and chemical or biological weapons or nerve agents.

According to the VA, the department will use service records and other resources to determine whether a veteran participated in a TERA. Veterans are not required to have a service-connected disability or file a compensation claim to be eligible for VA care. New enrollees will have access to a toxic exposure screening provided by their primary care physician and may be referred to specialty care depending on need.

They also will be assessed for placement in the VA's priority-based health system and referred to the Veterans Benefits Administration if they qualify for additional benefits. Priority group placement determines whether a veteran is required to make copayments for appointments or prescriptions, depending on treatment or the medications.

The Veterans Health Administration has set a goal to hire 52,000 employees this fiscal year, which, when factoring in attrition, should grow its workforce by 3%. The increases could help to absorb new patients, meet demand, and standardize -- or even improve -- wait times.

A Lasting Memento of the Nation's Thanks!

We added a very special event to our luncheon meeting on March 16th. The 50th Anniversary Commemoration of the Vietnam War is a Secretary of Defense initiative, authorized by Congress, to thank and honor Vietnam veterans for their service and sacrifice and to have their service during the Vietnam War publicly acknowledged.
