## **INTRODUCTION OF GUEST SPEAKER:**

Bruce Kosaveach, Director of Programs, introduced Chris Bain, SSgt, USA (Ret) will be the March luncheon meeting guest speaker. While in Iraq he was injured in an ambush where he and his team were hit by 3 mortars and he was shot twice. Chris actually died for 10 minutes, but was revived by his interpreter who gave him a blood transfusion on the battlefield. He woke up 14 days later in Walter Reed Medical Center where he spent 3 ½ years recovering from his injuries. Chris refused amputation of his arms and used the sheer force of his will to keep going. A new ground breaking procedure utilizing an implanted battery with sensors to his spine has brought his left side back to life.

## FINAL REMARKS:

Tom thanked Chris Bain for sharing his incredible and heroic story and presented Chris with the AZ MOAA pen and challenge coin.
